- 3. In case of Fresh/Duplicate/Replacement of Ration Card, addition/deletion of units and change of address two passport size family group photographs in respect of members mentioned in column 7 at page 1 are to be enclosed. (One photograph to be pasted).
- 4. For fresh ration card, a surrender or deletion certificate, issued by the rationing authority from where the applicant has migrated be attached with the application form along with allotment letter in case of Govt. accommodation. OR Voter Identity Card of Chandigarh parliamentary constituency in respect of major members and birth certificates in case of minor member along with specified affidavit is to be enclosed.
- 5. In the applicant is a Government servant, he should get the application form attested from the head of the Office. If an applicant is not a government servant, he should get the application form attested from any Gazetted officer of the city or any other persona authorized by the Government. In case of Rural Area form be got attested from the Sarpanch of the Village.
